Objectives

- Understanding why effective institutions is vital for SDG implementation
- Understanding institutional roles and responsibilities

- Strengthened understanding of the importance of stakeholder engagement in SDG implementation
- Explore and deepen knowledge on the role of companies in the context of SDG16, with a particular emphasis on target 16.5 (substantially reduce corruption and bribery in all their forms)
- Understand Target 16.2: End abuse, exploitation, trafficking and all forms of violence against and torture of children
- Understand Target 16.7: Ensure responsive, inclusive, participatory and representative decision making at all levels
- Understand target 16.b: Promote and enforce non-discriminatory laws and policies for sustainable development
